

RULES OF CONDUCT

Using the site: <http://javaday.org.ua/> You hereby agree to the following terms and conditions, which are the Rules of conduct for users of the site and participants of “Java Day 2017”.

“Java Day 2017” -Conference that unifies the developers’ community.

User (reader) - everyone who visits the address: <http://javaday.org.ua/>.

Participant (visitor) - everyone who bought the ticket on the website <https://2event.com/en/events/837259> previously have logined via Facebook, Google Plus, E-mail and accepted the "Regulations on provision of service 2event.com» (that is essentially a public offer) at the link <https://2event.com/uk/agreement>.

These Rules of conduct define the standards of conduct of the users (readers) of the site and participants (visitors) of the Conference and shall be carried out by each user and participant.

Ignorance of the Rules does not relieve from obligations to carry out it. Posting any message on the site automatically means Your consent with these Rules and obligation to follow them.

Providers of the Conference value highly of each participant and wish to make participation in the Conference not only useful but also enjoyable.

All Conference’s participants and site’s users shall adhere to the rules of professional communication and prevent the usage of offensive language, phrases that humiliate individuals, assault their dignity and honor.

Calls to forced changes of constitutional order of the state, assumption of State power, changes of administrative or State borders of Ukraine, calls to arms and invasion, riotous statements and any other calls, statements and/or actions aim at breach of the Laws of Ukraine, as wells as disorderly behavior, are strongly prohibited within the usage of the site, as well as within the Conference

Providers of the “Java Day 2017” are not responsible for speeches, statements, notifications and calls, their content and duration, speakers’ manner of communication, etc., as well as providers are not responsible for the content of advertising materials and information articles, users’ comments, published on the site or in social networks.

The opinion of authors of the articles may not coincide with ideas of the providers of “Java Day 2017”, but must be expressed strongly with the use of business language.

Providers of the “Java Day 2017” bring attention of Conference’s visitors that purchased ticket is not subject of return, except the cases directly described herein.

Purchased ticket for the Conference shall be subject of return only in following cases and only in case when Providers informed participants/buyers by openly and publicly notification:

- 1- Provider calls off the Conference;
- 2- Provider changes the date of the Conference after purchase of ticket and the participant/buyer does not agree with such changes and wishes to return the ticket (not to change for another one).

In the above mentioned cases the participant/buyer has the right to demand the seller of ticket within ten (10) working days from the moment of Provider’s notification (about cancelation of the Conference or changes of date of the Conference) to return the nominal price of the ticket, which equals 90% of the total cost (the cost of Seller’s fees is non-refundable).

Take a note that the place of the Conference, indicated in the ticket, may be changed by the Provider. In any case the city of Conference – Kyiv, shall not be subject of any changes. Participants/buyers shall monitor any changes of place of the Conference on website <http://javaday.org.ua/> up to date of the Conference

Please, be aware that in case if failure to fulfill or improper fulfillment of obligations by the Provider is a consequence of force-majeure: fires, floods, earthquakes, strikes, mass unrest, riots, war or actions/decisions of the State authorities that make impossible to fulfill the Provider obligations, and if these circumstances directly affected the fulfillment of obligations by the Provider **the cost of the ticket** may only be partially reimbursed (or, in the extreme case, may be not reimbursed at completely).

Providers hope that all participants will receive a satisfaction and a lot of new useful knowledge within the Conference, and with this purpose we make every effort.
